- Collaborate with VP of Research and Evaluation on measurement and reporting for all programs
- Lead the rollout of the newly reimagined girl's curriculum and facilitate program leader and coaches' training
- o Play a leadership role in the Annual Salute to Women in Sports Awards Gala

- Continue growing the Student-Athlete Mentoring Program

- Oversee contracts and invoicing for all athlete-related events, grants programs, and other community impact initiatives
- o Provide comprehensive program reporting for WSF donors, sponsors and partners

- Supervise a high-functioning team in a manner that demonstrates clear roles and responsibilities, excellent work quality, professional growth and development, and commitment to diversity in hiring

- Working knowledge of women's sports and female athletes

- o Strong organizational skills with attention to detail
